## a. SLWCD Projects & Grants

- i. SLWCD Flood Damage Reduction Planning Study (Miles Hebert)-
  - 1. Miles shared the agenda for EMH&T's Flood Reduction Planning Study and presented the PowerPoint
  - 2. Miles discussed the history of the project. Went over the origin and powers of SLWCD South Fork Licking River & Raccoon Creek.
  - **3.** Discussed the 1980 Watershed Plan & Environmental Impact Study that was completed by Soil Conservation Service
    - a. An updated plan was created in 2009-2010 by NRCS but was never completed
  - **4.** Miles shared and went over the current project timeline between SLWCD and the Licking County Commissioners
  - **5.** Miles discussed the South Fork Licking River & Buckeye Lake part of the watershed. Went over the flooding/damage that has happened in recent years.
  - **6.** The Channel Maintenance Plan was discussed- includes South Fork & Raccoon Creek
    - a. Mapping of 3, 4 & 5 watercourses
    - b. Log jam identification by size
    - c. Field assessment and scoring
    - d. Mapping of channel easements
    - e. Acquisition costs
  - 7. Miles then discussed the Flood Damage Reduction Study
    - a. Shared goals, solutions, benefits, cost
    - b. Support for the future update of the 1980s Watershed Work
  - **8.** Miles went over the Hydrologic & Hydraulic models
    - a. Hydrologic
      - i. HEC-HMS model of the SFLR
      - ii. Watershed outside of the 2D model area (except the watershed area of Buckeye Lake)
    - b. Hydraulic~ ms consultants
      - i. 2D HEC-RAS model of 28 square miles surrounding SFLR between Kirkersville & Heath
      - ii. The March 2020 flooding event was discussed
      - iii. Miles went over dry dams
      - iv. Discussed the finding from the ms consultants Flood Mitigation Study
  - **9.** Miles went over the cost of 7 dry dams
  - 10. Miles ended the presentation stating they are trying to pick up where all others have left off to finally get a completed study.
