V. Old Business

a. SLWCD Projects & Grants

- i. SLWCD Flood Damage Reduction Planning Study (Miles Hebert)-
 - 1. Report provided from Miles requesting additional funds
 - 2. Hawthorne discussed the report and explained approval would be at the next meeting
 - 3. Hawthorne discussed the state agency meeting at Van Buren Acres
 - 4. Hawthorne suggested SLWCD should form a budget committee

ii. Raccoon & Lobdell Creek Debris & Field Study and Snag & Clearing Grant (Kyle Seitz)-

- 1. Seitz discussed email stating they are nearing the end of phase 1, just waiting on reports to be finalized
- 2. Seitz went over the funding:
 - a. Phase 1 \$100,000.00 at 100% funding
 - b. Phase 2 \$200,000.00 at 50% funding for implementation
 - i. Planning process phase
 - 2. Phase 3 \$200,000.00 at 65% funding
 - i. Implementation phase
 - d. SLWCD is committed to \$94k for the first phase
- **3.** Discussed the funding SLWCD owes and funding/reimbursement options.
- **4.** Total cost share is approximately \$170,000.00

b. Watershed Update

i. Licking County SWCD (Kristy Hawthorne & Kyle Seitz)-

- 1. Seitz discussed the Kirkersville 9-Element Plan, stated he has finished the edits and waiting on final approval
- **2.** Went over the H2Ohio funds for wetlands
- **3.** Seitz stated they are looking into applying for the OEPA grant for Raccoon Creek, \$7,500.00 for 9-Element plans
- **4.** Hawthorne stated the last round of questions have been answered for the FEMA grant

ii. Fairfield County SWCD (Josh Troyer)-

- 1. Honey Creek 319 grant is moving forward
- iii. Perry County SWCD (David Snider)- no updates

- a. Grant NOFOs
 - i. H2Ohio Wetland Grant
 - 1. LCSWCD is applying, currently looking for locations
 - ii. AmeriCorps
 - 1. LCSWCD is getting 2 members, one for education and one for Buckeye Lake as a watershed coordinator. Hawthorne discussed the program.
 - **a.** Funding for the Buckeye Lake member was provided by Buckeye Lake for Tomorrow and Buckeye Lake Region Corporation.

iii. MWCD PWM Grant
