Old Business

- a. Projects and Funding discussion of Project list Costs, and Licking County number of parcels.
  - i. Discussions of costs relating to various listed projects.
- b. Denise discussed remote mapping of stream blockage sites the Licking County Soil & Water Conservation District (LCSWCD) had identified from aerial photos.
  - i. Breanna discussed her approach to identification of stream blockage and degree of blockage. She had GIS maps of several of the large streams in the Conservancy District with enlargements of examples of the information gathered, particularly Raccoon Creek and Lobdell Creek.
  - ii. It is noted that blockages & logjams occur throughout the watershed and seem to result in substantial sediment dislodged and transported.
  - iii. The goal will be to review all the streams with the same criteria so we can estimate a cost to remediate the streams. The major streams and tributaries will be identified to address.
- c. Linda reported Matt Baumann had stated issues at the east end of Buckeye Lake have slowed (relating to a place to put dredged material) due to archeological studies.
- d. We have heard nothing regarding the Kirkersville Feeder. Dan will contact Bob Cumbow regarding any information available.

a. Discussion took place regarding bridge updates at time of reconstruction and keeping local officials informed & that they can ask for higher pass-through rates, for example.

- b. Denise discussed the H2Ohio program and some of the focus it is said to have and how the LCSWCD can interest landowners in the practices in the program.
- c. Linda had discussed Conservancy District Plan update with Boris at Muskingum Watershed Conservancy District, and we should have requests for funding ready to submit to them.
- d. Kevin plans to attend the LCSWCD March 20 meeting where they develop program goals.
- e. Our Board will support the LCSWCD increase in staffing. There board meeting is upcoming. Kevin and Linda plan to attend.
