 - **a.** Jennifer discussed FRAMEWORK, a public and private collaboration to coordinate local government comprehensive plans for anticipated development in Licking County.

 - a. SLWCD Projects & Grants
 - i. SLWCD Flood Damage Reduction Planning Study (Miles Hebert)-
 - 1. Miles discussed the waterway and channel maintenance plan and stated the next move is to get into the field to look at the priority log jams that have been identified. Need to access the properties.

- 2. Created a scorecard that will help rank and prioritize the log jams. Also have a cost estimating tool to help document individual locations and project costs.
- 3. Discussed the hydrology modeling and stated the work is done and they are now ready to coordinate with ms consultants and their 2D model. Need to merge the two models. Once they have the combined model, they can have their discussion with USGS about where the modeling stands.
