## **ORDER**

This matter came on before this Conservancy Court for the Annual Meeting of the South Licking Watershed Conservancy District, on December 19, 2019 at 2:00 p.m.

The Directors of the South Licking Watershed Conservancy District were in attendance. The Directors at the time the Annual Meeting commenced were Dan Blatter and Linda Nicodemus. Robert Cumbow served as a Director for the District but resigned effective July 28, 2019. Legal counsel for the District, Brian C. Reed, was also in attendance. Judge Tina M. Boyer was not present at the meeting.

The first item addressed by the Court was the Motion for the Appointment of Kevin Elder as Director to fill the vacancy left by Robert Cumbow. The Court reviewed the written application completed by Kevin Elder and heard from him on the record as to his credentials and experience. The Court then granted the motion to appoint Mr. Elder as the third Director for the District and administered an Oath of Office which was signed before the Court. The Oath of Office and Order were filed with the Clerk of Court's after the annual meeting adjourned.

The Directors then presented for approval by the Court their written Annual Report for the time period December 1, 2018 to November 29, 2019. The Report's principle author, Dan Blatter discussed the Report at length. Additional comments were made by Linda Nicodemus about the meetings and developments of the SLWCD.

Attached hereto as Attachment "A" is a sheet signed by those in attendance at the Annual Meeting. The Court solicited comments from those in attendance. A record of the meeting was made by the Court. The topics discussed at the meeting included: the continued presence of a significant log jam located on the South Fork of the Licking River that restricts the downstream flow of water. The Directors discussed the need for funding to remove the log jam and discussed the estimated fees to accomplish that work. The Directors also discussed the completion of Buckeye Lake dam rehabilitation project and interest in the outcome of a study of the Kirkersville Feeder condition.

There was additional discussion about a Buckeye Lake Drainage Improvement Project which focuses on areas north of Buckeye Lake. Discussion was had about the Buckeye Lake HUC-12 document which is now under formal review. The HUC is within the SLWCD boundary and would be incorporated into the SLWCD's plan.

The Directors briefly discussed the City of Heath's erosion mitigation efforts and the estimated costs associated with that project.

The issue of funding was discussed, including the need for exploration of potential assessment to generate funds for the projects discussed herein. The Court and the Directors expressed an intent to meet in the coming months to move forward with funding/assessment discussions.

There appearing to be no further matters for consideration before the Court and District, the Annual Meeting was then concluded and adjourned.

Being satisfied with the contents of the Annual Report, the Court hereby approves the same and has directed counsel to file the Report with the Clerk of Courts.
